- It is no longer a requirement to confirm with a Western Blot test. If the total antibody EIA test is positive, it will reflex to an IgG and an IgM EIA antibody test.



Dear Valued Client,

Effective February 28, 2022, Labcorp began offering a new Lyme disease serology reflex testing profile, Lyme Disease Total Antibody With Reflex to Immunoassay [164226], to support timely and easy interpretation of Lyme serology results to aid in the diagnosis of Lyme disease. As a result of this new test offering, the following Lyme disease antibody profiles will be discontinued effective April 25, 2022: Lyme Disease Antibodies, Total and IgM, With Reflex to Line Blot [258004]; Lyme Disease, Antibody Total with Reflex [160325]; and Lyme Disease, IgM, Early Test with Reflex [160333].

Labcorp has made this change in correlation to current guidelines and recommendations of the FDA approval of enzyme immunoassay (EIA) as the second test method in our Lyme Disease testing algorithm known as a modified two-tiered testing (MTTT) algorithm, which demonstrates improved performance characteristics.

The new algorithm is outlined below:
